2.2.1 Lists

1. Numbered lists are used if the order of the primary list elements is of importance.

3 Support for Time To Duration

The Time To Duration (TTD) Showtiming function is now supported in the ClockClient. The ClockManager automatically detects if a show is started in TTD mode. If running in TTD mode the ClockClient will set the Realtime clock to zero counting forward from the begin of the show. This reflects the behaviour of the iNEWS Showtiming clocks.

For TTD to work make sure that the air-date fields of all stories in the rundown are empty. If one of the fields is not empty and TTD is started the ClockManager may fail to detect the TTD mode. Also remove the contents of the air-date fields if you restart in TTD mode.

Also make sure that the air-date fields of all stories in the rundown are empty if the rundown was clocked in TTD mode and will now be clocked with normal Showtiming. If normal Showtiming is started and the air-date fields of the rundown still contain TTD times from a previous TTD run the ClockManager may detect TTD mode accidentally.

MAKE SURE THE AIR-DATE FIELDS OF A RUNDOWN ARE EMPTY BEFORE:

- **YOU START SHOWTIMING WITH TTD**
 - **YOU RESTART SHOWTIMING WITH TTD**
 - **YOU START NORMAL SHOWTIMING ON A RUNDOWN THAT WAS STARTED WITH TTD BEFORE.**
